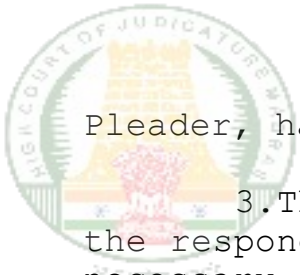
ORDER

3.The learned Additional Government Pleader appearing for the respondents has contended that the second respondent has given necessary permission for conducting Karakattam for the first day and rejected Adalpadal for the second day by way of passing the impugned order.

4.Considering the fact that the festival mentioned in the petition is going to be conducted for two days, the rejection order passed by the second respondent is liable to be quashed.

5.In fine, this writ petition is allowed in part without costs and the impugned order dated 15.03.2017 passed by the second respondent in C.No.55/Mike/B2PS/2017 is quashed in part. The second respondent is directed to look into the representation, dated 15.03.2017 and dispose of the same within a period of two days.
