4. Having regard to the limited scope of the prayer in the Writ petition, without expressing any opinion on the merits of the matter, this Court is inclined to issue the following direction:-

"The first respondent is directed to consider and dispose of the representation of the petitioner, dated 10.08.2016, on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order."

5. Accordingly, the Writ petition is disposed of. No costs.
