This Writ petition is for issuing a Writ of Mandamus, the petitioner has given a representation, dated 18.02.2017, seeking refund on the basis of the order of the Sales Tax Appellate Tribunal(Additional Bench), Madurai, in M.T.S.A.No.47 of 2013, dated 08.07.2015. Hence, the learned counsel for the petitioner submits that the petitioner will be satisfied if a direction is issued to the respondent to consider the representation of the petitioner, dated 18.02.2017, within the time stipulated by this Court.

5. Having regard to the limited scope of the prayer in the Writ petition and the submissions made by the learned counsels on either side, without expressing any opinion on the merits of the matter, this Court is inclined to issue the following direction:-

"The respondent is directed to consider the representation of the petitioner, dated 18.02.2017, and pass appropriate orders on merits and in accordance with law, within a period of six weeks from the date of receipt of a copy of this order."

6. Accordingly, the Writ petition is disposed of. No costs.
