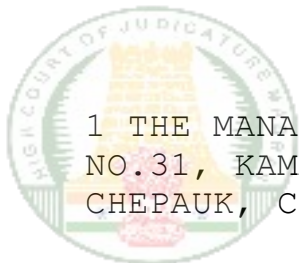

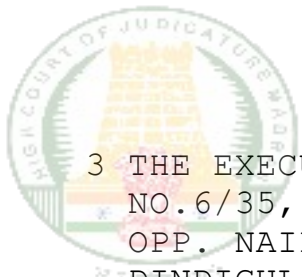

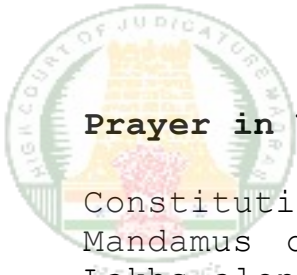

3.Recording the submission made by the learned counsel for respondents, these Writ Petitions are disposed of by directing the respondents to settle the amounts in favour of the petitioner as admitted by the learned counsel for the respondents,



within a period of ten months from today. As regards payment of interest, it is open to the petitioner to claim or workout his remedies in the manner known to law. No costs.
