ORDER

This Writ Petition has been filed under Article 226 of the Constitution of India praying to call for records relating to the impugned order dated 21.03.2017 passed by the second respondent in respect of Adal Padal Programme and quash the same, by way of issuing a Writ of Certiorarified Mandamus.



3. It is seen from the records that the second respondent has rejected the permission simply on the ground of law and order problem. The reason assigned by the second respondent cannot be accepted. Under the said circumstances, this Court is inclined to pass the following order.

4. In fine, this Writ Petition is allowed in part without costs and the impugned order dated 21.03.2017 passed by the second respondent is quashed. However, the second respondent is directed to consider the representation afresh and pass suitable orders on merits.
