2.We give liberty to the petitioner to submit a comprehensive representation to the District Collector, Thanjavur District. In case, any such representation is given, the same shall be considered and disposed of by the District Collector, on merits and in accordance with law after issuing notice to the alleged encroachers. Such exercise shall be completed within a period of three months from the date of receipt of representation.

3.The writ petition is disposed of with the above direction. No costs.
