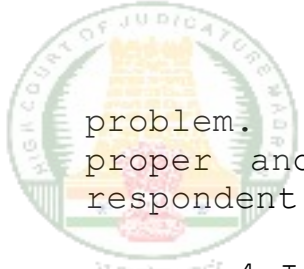
ORDER

problem. The reason assigned by the second respondent is not proper and therefore the impugned order passed by the second respondent is liable to be quashed.

4. In fine, this writ petition is allowed in part without costs and the impugned order dated 22.03.2017 passed by the second respondent is quashed. The second respondent is directed to consider the representation dated 20.03.2017 afresh and pass suitable orders within a period of two days.
