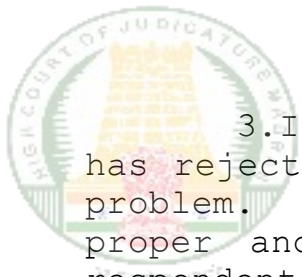

ORDER

[Order of the Court was made by A.SELVAM, J.]

This writ petition has been filed under Article 226 of the Constitution of India praying to call for records relating to the impugned order dated 27.03.2017 passed by the second respondent and quash the same and also for directing the respondents to give permission for conducting Cultural Programme in the place mentioned in the petition, by way of issuing a writ of certiorarified mandamus.

2.Mr.T.S.Mohammed Mohideen, learned Additional Government Pleader, has taken notice for the respondents.



3.It is seen from the records that the second respondent has rejected the permission simply on the ground of law and order problem. The reason assigned by the second respondent is not proper and therefore the impugned order passed by the second respondent is liable to be quashed.
