3.It is seen from the records that the petitioner has given a representation and the same has been rejected by the second respondent simply on the ground of law and order problem. The reason assigned by the second respondent is not proper. Under the said circumstances, this Court is inclined to pass the following order.

4.In fine, this Writ Petition is allowed in part without costs and the rejection order passed by the second respondent dated 26.03.2017 is quashed. The second respondent is directed to look into the representation dated 26.03.2017 afresh and pass suitable orders on merits within a period of two days. Consequently, connected Miscellaneous Petition is closed.
