The writ petitioner is aggrieved by the proposal to construct the Village Panchayat Service Centre at Kovilangulam



Village, in a land that has been earmarked as 'kalam' in the revenue records. The writ petitioner however wants the Service Centre to be put up but not in the site meant for threshing. He has given a representation dated 12.08.2016 in this regard.

2. This Court directs the third respondent to take action on the said representation and put up the Service Centre on any land except the place shown as 'Kalam' in the revenue records.

3. With this observation, this Writ Petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
