ORDER

This Writ Petition has been filed under Article 226 of the Constitution of India praying to call for records relating to the rejection order dated 28.03.2017 passed by the second respondent and quash the same and also for giving necessary direction to the respondents to give permission for conducting Aadal Padal Programme in the place mentioned therein, by way of issuing a Writ of Certiorarified Mandamus.

3. It is seen from the records that the petitioner has given a representation and the same has been rejected by the second respondent simply on the ground of law and order problem. The reason assigned by the second respondent is not proper. Under the said circumstances, this Court is inclined to pass the following order.

4. In fine, this Writ Petition is allowed in part without costs and the rejection order passed by the second respondent dated 28.03.2017 is quashed. The second respondent is directed to look into the representation alleged to have been given by the petitioner afresh and pass suitable orders on merits within a period of two days.
