ORDER

This writ petition has been filed under Article 226 of the Constitution of India praying to call for records relating to the impugned order passed by the second respondent dated 24.03.2017 and quash the same and also for directing the respondents to give permission for conducting Adalpadal Programme in the place mentioned in the petition, by way of issuing a writ of Certiorarified Mandamus.

3.It is seen from the impugned order dated 24.03.2017 that the second respondent has given necessary permission for



conducting Karakattam, but rejected permission for performing Adal Padal programme simply on the ground of law and order problem.

4. Considering the fact that the second respondent has already given permission for conducting Karakattam, this Court is inclined to pass the following order.

In fine, this writ petition is allowed in part without costs and the impugned order dated 24.03.2017 passed by the second respondent is partly quashed so far as permission sought for conducting Adal Padal Programme. The second respondent is directed to look into the representation alleged to have been given by the petitioner and pass suitable orders within a period of two days.
