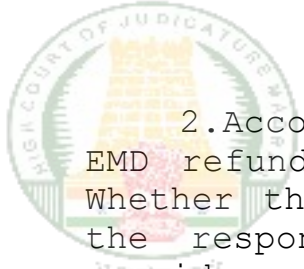

However, as a representation made by the petitioner seeking for refund is still pending, this Writ Petition is disposed of with a direction to the second respondent to consider the representation of the petitioner, dated 07.07.2016, and pass orders on the same on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.
