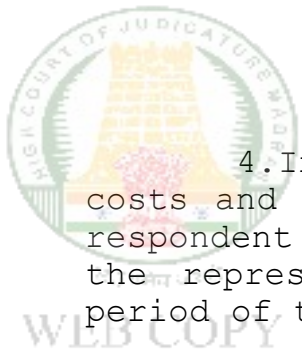
#### ORDER
