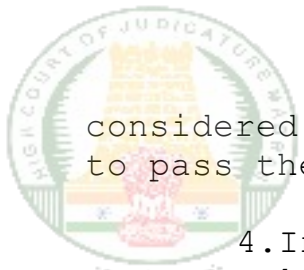
### ORDER
