The writ petitioner seeks removal of the encroachment allegedly made by the fifth respondent herein in Survey No.842, at Gosugundu Village, Sattur, Virudhunagar District.

If the fifth respondent is occupying any public land in excess of what has been assigned in his favour, it is open to the third respondent to take appropriate action in accordance with law.
