**O R D E R**

This Writ petition has been filed by the petitioner for issuance of a Writ of Mandamus, directing the respondents to give the promotion to the petitioner as Assistant Manager in the respondent Transport Corporation from 05.10.2015.

"The respondents are directed to consider the representation of the petitioner, dated 13.01.2016, in the light of the Rule-60 of Common Service Rules, and pass appropriate orders on merits and in accordance with law, within a period of six weeks from the date of receipt of a copy of this order."
