This Writ petition has been filed by the petitioner for issuance of a Writ of Mandamus, directing the respondents to give the promotion to the petitioner as Assistant Manager in the respondent Transport Corporation from 19.11.2015.

2. Though the Writ petition is for issuing a positive direction, the learned counsel for the petitioner submit that the petitioner will be satisfied if a direction is issued to the respondents to consider the representation of the petitioner, dated 13.01.2016.
