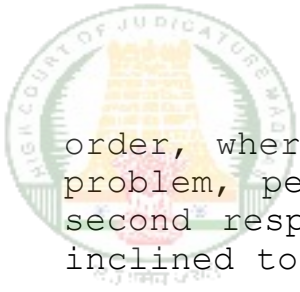
ORDER

This Writ Petition has been filed under Article 226 of the Constitution of India praying to call for records relating to the impugned order passed by the second respondent and quash the same, by way of issuing a Writ of Certiorarified Mandamus.

2.Mr.T.S.Mohammed Mohideen, learned Additional Government Pleader, has taken notice for the respondents.

3.It is seen from the records that the petitioner has given a representation for the purpose mentioned therein, but the second respondent has rejected the same by way of passing the impugned



order, wherein it has been simply stated that due to law and order problem, permission cannot be granted. The reason assigned by the second respondent cannot be accepted and therefore this Court is inclined to pass the following order.
