Ltd. represented by its Director Rajendra Sheth No.7C, Second Canal Cross Road Gandhi Nagar Adyar, Chennai 600 020 vs. The Assistant Commissioner of Police, J-2, Adyar Police Station, Adyar, Chennai 600 020 and another, reported in 2016 (2) CTC 286. However, on instructions, learned Additional Government Pleader submitted that on the complaint given by the petitioner, a petition enquiry has been conducted and the same was closed on 27.04.2017.
