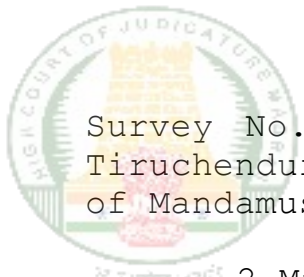
PRAYER: Writ Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus, directing the respondents herein not to take any steps to dispossess the petitioner from petitioner's shop comprised in Old Survey No.241, New Survey No.1494/83 measuring an extent of 0.03.5 cent of land more fully a shopping unit (having 133.75 sq. feet) situated at Tiruchendur Town, Thoothukudi District and except by due process of law by considering the petitioner's representation dated 15.04.2017.
