The petitioner submitted representation to the Tahsildar, Uthamapalayam Taluk on 04 January, 2017 requesting to take action to remove the encroachment made on the L.F.Road in T.S.No.4/2A-1, Nathan Survey Nos.755/1, 756/1, 758/1, Block NO.25 Ward No.31 and in Survey Nos.2198, 2198/1B in Cumbum Mettu Highways. Since



follow up action was not taken, the petitioner is before this Court.

2. We direct the respondents 3 to 5 to consider and dispose of the representation of the petitioner on merits and as per law, after issuing notice to the alleged encroachers. Such exercise shall be completed within a period of four months from the date of receipt of a copy of this order.

3. The writ petition is disposed of with the above direction. No costs. Consequently, connected miscellaneous petition is closed.
