The writ petitioner, aggrieved by the alleged illegal demolition of her house, has come up with this writ petition, seeking relief of provision of alternative place and for compensation.

2. We are not inclined to consider the prayer as regards the claim for compensation. However, we direct the first respondent to consider the representation of the writ petitioner, dated



28.02.2017, seeking allotment of an alternative site. If the writ petitioner is otherwise eligible, the first respondent is directed to consider favourably.

3. With the above direction, the Writ Petition is disposed of.
