ORDER

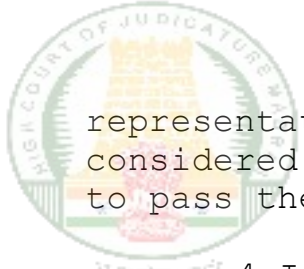
[Order of the Court was made by A.SELVAM, J.]
