PRAYER: Writ Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Certiorarified Mandamus, to call for the records relating to impugned order passed by the second respondent dated 15.04.2017 and quash the same as illegal consequently direct the second respondent to grant permission to conduct Innisai Katcheri (Orchestra) programme on 17.05.2017 at West Muppidathi Amman Kovil, Vikramasingapuram, Ambasamuthiram Taluk, Tirunelveli District based on petitioner's representation dated 22.04.2017.

ORDER

This Writ Petition has been filed under Article 226 of the Constitution of India praying to call for records relating to the impugned order dated 15.04.2017 passed by the second respondent and quash the same and also for giving necessary direction for conducting Innisai Katcheri programme in the place mentioned therein, by way of issuing a Writ of Certiorarified Mandamus.



2.Mr.K.Guru, learned Additional Government Pleader, has taken notice for the respondents.

3.It is seen from the records that the petitioner has given a representation for the purpose mentioned therein, but the second respondent has rejected the same by way of passing the impugned order dated 15.04.2017, wherein it has been simply stated that due to law and order problem, permission cannot be granted. The reason assigned by the second respondent cannot be accepted and therefore this Court is inclined to pass the following order.

4.In fine, this Writ Petition is allowed in part without costs and the impugned order dated 15.04.2017 passed by the second respondent is quashed. The second respondent is directed to look into the representation alleged to have been given by the petitioner afresh and pass suitable orders on merits within a period of two days.
