If as a result of the said enquiry, it is noticed that there is any encroachment, the third respondent shall take action to remove the said encroachment after due process of law and after notice to the interested parties. Such exercise shall be completed within a period of three months from the date of receipt of a copy of this order.

4.The writ petition is disposed of with the above direction. No costs. Consequently, connected miscellaneous petition is closed.
