ORDER

consider the representation of the Petitioner, dated 31.03.2017 on merits and in accordance with law and pass orders on the same, after verifying the audit report, as expeditiously as possible, preferably within a period of ten weeks from the date of receipt of a copy of this order.

7. With the above direction, the Writ Petition stands disposed of. No costs.
