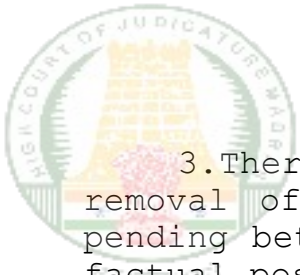
Prayer: Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the 2nd and 3rd respondents to provide police protection for the removal of Seemai karuvelam Trees from the land in Survey Nos.119/16B1, 119/16B2, 135/1, 142/10, 142/21, 142/4, 142/5, 142/6, 57/7A1A, 59/16 for an extent of 3 acres 50 cents in Kovilpappakudi Village, Patta No.295, Madurai North Taluk Madurai District on the petition of the petitioner dated 28.03.2017.
