O R D E R

2. Heard the learned Counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondents.

3. Mr.Mr.G.Kasinatha Durai, learned Standing Counsel for the respondents. By consent, the Writ petition itself is taken up for final disposal.



4. Though the Writ petition is for issuing a positive direction, the learned counsel for the petitioner submits that the petitioner will be satisfied if a direction is issued to the respondents to consider the representation of the petitioner, dated 06.02.2017.

5. Considering the limited scope of the request of the learned counsel for the Writ petitioner, without expressing any opinion on the merits of the matter, this Court is inclined to issue the following direction:-

"The respondent is directed to consider the representation of the petitioner, dated 06.02.2017, and pass appropriate orders on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order."
