This Writ Petition has been filed under Article 226 of the Constitution of India praying to direct the respondents 1 and 2 to grant permission and adequate police protection for celebrating birth anniversary of Perumbidugu Mutharayar on 23.05.2017 in the place mentioned therein, by way of issuing a Writ of Mandamus.



2.Mr.M.Govindan, learned Special Government Pleader, has taken notice for the respondents 1 and 2. Considering the nature of the relief sought in the Writ Petition, notice need not be sent to the third respondent.
