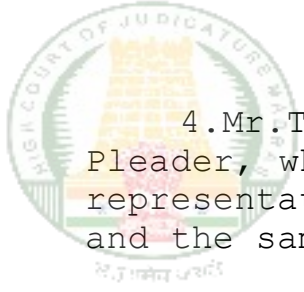
ORDER

2.Heard the learned counsel for the petitioner.

3.The learned counsel for the petitioner submitted that the petitioner has given a complaint in respect of cheating of Rs.4,00,000/- by the accused and the earlier complaint was closed by the respondent Police and again he has sent another complaint to the second respondent dated 30.03.2017, but the said complaint is still enquired by the respondents herein. Hence, the petitioner has filed the present Writ Petition seeking a direction in the
