3. It is seen from the records that on 28.11.2016 a complaint has been given to the first respondent by the petitioner and the same has not been considered. Under the said circumstances, this Court is inclined to pass the following order.

In fine, this Writ petition is allowed in part without cost. The first respondent is directed to look into the complaint dated 28.11.2016 alleged to have been given by the petitioner and dispose of the same within a period of one week.
