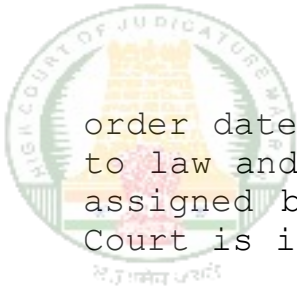
ORDER

order dated 25.04.2017, wherein it has been simply stated that due to law and order problem, permission cannot be granted. The reason assigned by the respondent cannot be accepted and therefore this Court is inclined to pass the following order.

4. In fine, this Writ Petition is allowed in part without costs and the impugned order dated 25.04.2017 passed by the respondent is quashed. The respondent is directed to look into the representation alleged to have been given by the petitioner afresh and pass suitable orders on merits within a period of two days.
