3.It is seen from the representation dated 10.04.2017 that some encroachments are in existence in Wakf property. Only under the said circumstances, the said representation has been given.

4.Considering the fact that the property belongs to Wakf, the proper authority to take action is Tamil Nadu Waqf board. Under the said circumstances, the following direction can be given.

"The petitioner is directed to give proper representation to the Tamil Nadu Waqf Board."
