This Court directs the second respondent to consider the said representation and dispose of the same and take appropriate action in accordance with law within a period of three months from the date of receipt of a copy of this order. The second respondent shall give notice to the fifth respondent before passing any order.

3. Accordingly, this writ petition stands disposed of. No costs.
