PRAYER: Writ Petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Mandamus directing the respondent to grant permission to perform the cultural programme of Adal Padal on 14.05.2017 at night 08.00 P.M., to 12.00 A.M., at Arulmigu Kaliyamman Kovil which is situated at Jakkampatti, Andipatti, Theni District and to provide adequate police protection based on the petitioner's representations dated 04.05.2017.

O R D E R

This Writ Petition has been filed for issuance of a Writ of Mandamus, directing the respondent to grant permission to perform the cultural programme of Adal Padal on 14.05.2017 at night 08.00 P.M., to 12.00 A.M., at Arulmigu Kaliyamman Kovil which is situated at Jakkampatti, Andipatti, Theni District and to provide adequate police protection based on the representations dated 04.05.2017.

2.Learned counsel for the petitioner submitted that the festival of the said temple is scheduled to be held on 14.05.2017. The petitioner and other villagers have decided to organise "Aadal Padal programme" in Jakkampatti, Andipatti, Theni District, in connection with Arulmigu Kaliyamman Kovil Thiruvizha Festival, therefore, the petitioner submitted a representation, dated 04.05.2017, to the respondent, requesting them to grant permission therefor. Since, no order has been passed on the said representation, the petitioner has filed the present writ petition, for the above mentioned relief.

3.Learned Special Government Pleader who takes notice for the respondents, submitted that the respondents have no serious objection to grant permission to conduct "Aadal Padal programme" in Jakkampatti, Andipatti, Theni District, in connection with Arulmigu



Kaliyamman Kovil Thiruvizha Festival. His submission is placed on record.

4. Considering the submissions made on either side, this Court passes the following order:-

"The respondent is directed to grant permission to the petitioner to conduct "Aadal Padal programme" in Jakkampatti, Andipatti, Theni District, in connection with Arulmigu Kaliyamman Kovil Thiruvizha Festival, subject to the following conditions:

i) The event shall be conducted in an organised and peaceful manner without causing law and order problem.

ii) There shall not be any obscene or vulgar scenes during the dance performance by any one of the participants or others.

iii) The dance performance shall be restricted between 6.00 p.m and 11.00 p.m, on 14.05.2017.

iv) If there is any violation of the above said conditions, the respondent or the duly authorised officer is entitled to take necessary action as per law and stop such performance.

5. With the above directions, this Writ Petition is disposed of. No costs.
