Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondent to grant permission to perform the cultural program of "Adal Padal" on 14.05.2017 night at Shri.Muthumariamman, Shri.Kaliyamman and Shri.Madurai Veeran temple, Thondamanginam, Kadavur Taluk, Karur District and to provide adequate police protection based on the petitioner's representation dated 05.05.2017.

O R D E R

This Writ Petition has been filed for issuance of a Writ of Mandamus, directing the respondent to grant permission to perform the cultural program of "Adal Padal" on 14.05.2017 night at Shri.Muthumariamman, Shri.Kaliyamman and Shri.Madurai Veeran temple, Thondamanginam, Kadavur Taluk, Karur District and to provide adequate police protection based on the petitioner's representation dated 05.05.2017.

2.Learned counsel for the petitioner submitted that the festival of the said temple is scheduled to be held on 14.05.2017. The petitioner and all the residents of village have decided to organise "Aadal Padal programme" on 14.05.2017 night, in connection with Shri.Muthumariamman, Shri.Kaliyamman and Shri.Madurai Veeran temple, Thondamanginam, Kadavur Taluk, Karur District. Therefore, the petitioner submitted a representation, dated 05.05.2017, to the respondent, requesting them to grant



permission therefor. Since no order has been passed on the said representation, the petitioner has filed the present writ petition, for the above mentioned relief.

3. Learned Special Government Pleader, who takes notice for the respondent, submitted that the respondent has no serious objection to grant permission to conduct "Aadal Padal programme" on 14.05.2017 night, in connection with Shri.Muthumariamman, Shri.Kaliyamman and Shri.Madurai Veeran temple, Thondamanginam, Kadavur Taluk, Karur District. His submission is placed on record.

4. Considering the submissions made on either side, this Court passes the following order:-

"The respondent is directed to grant permission to the petitioner to conduct "Aadal Padal programme" on 14.05.2017 night, in connection with Shri.Muthumariamman, Shri.Kaliyamman and Shri.Madurai Veeran temple, Thondamanginam, Kadavur Taluk, Karur District, subject to the following conditions:

i)The event shall be conducted in an organised and peaceful manner without causing law and order problem.

ii)There shall not be any obscene or vulgar scenes during the dance performance by any one of the participants or others.

iii)The dance performance shall be restricted between 6.00 p.m and 11.00 p.m. on 14.05.2017.

iv)If there is any violation of the above said conditions, the respondent or the duly authorised officer is entitled to take necessary action as per law and stop such performance.

5. With the above directions, this Writ Petition is disposed of. No costs.
