However, this Court considers it is for the respondents 2 & 3 to look into the issue and if the obstruction is by encroachment they shall proceed in accordance with law.

8.Therefore, the writ petition is disposed of directing the respondents 2 & 3 to consider the representation of the petitioner dated 16.05.2017 on merits and in accordance with law, by issuing notice to the petitioner and as well as the 4th respondent and after conducting proper survey of land in S.No.1030, Perumalthevanpillai Village, Pillaiyarkulam revenue Village, Srivilliputtur Taluk also and if the obstruction mentioned above is by encroachment directed to remove same after following due process of law. The said exercise shall be completed within a period of eight weeks from the date of receipt of copy of this order. No costs.
