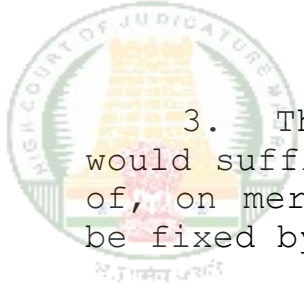

Till then, there shall be an order of status quo as on today.
