O R D E R

This Writ petition has been filed by the petitioner for issuance of a Writ of Mandamus, directing the respondents to grant permit to the petitioner to run the spare mini bus based upon the application dated 27.06.2016.

2. Heard the learned counsel appearing for the petitioner and the learned Additional Government Pleader, who takes notice for the respondents. By consent, the Writ petition itself is taken up for final disposal.

Though the Writ petition is filed to issue a Writ of Mandamus, to give positive direction to the respondents to grant permit to the petitioner, the learned counsel for the petitioner submitted that the petitioner will be satisfied if a direction issued to respondents to consider the petitioner's application dated 27.06.2016 and pass appropriate orders within a time stipulated by this Court.
