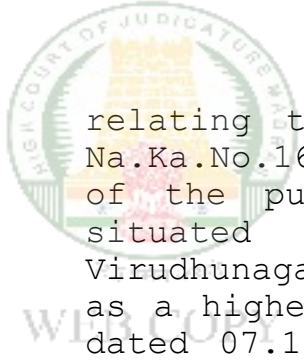

PRAYER in W.P (MD) No. 22633/16: Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Declaration declaring that the tender result is illegal calling for the records



relating to the impugned order passed by the 1st respondent in Na.Ka.No.16/2016/C2 dated 26.10.2016 pertaining to the maintenance of the public toilet and collecting amount from the customers situated near Madurai Vembakottai Bus Stand, Sattur Taluk, Virudhunagar District and consequently declare that the petitioner as a highest bidder as per the notification of the 1st respondent dated 07.10.2016 in collecting money from the user of the public paid toilet situated near Madurai Vembakottai Bus Stand, Sattur Taluk, Virudhunagar District for a period of three years (i.e., 2016-17 to 2018-19).

PRAYER in W.P(MD)No.22634/16: Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Declaration declaring that the tender result is illegal for the records relating to the impugned order passed by the 1st respondent in Na.Ka.No.16/2016/C2 dated 26.10.2016 pertaining to the maintenance of the public toilet and collecting amount from the customers situated at Vellakarai Road, Sattur Taluk, Virudhunagar District and consequently declare that the petitioner is a highest bidder as per the notification of the 1st respondent dated 07.10.2016 pertaining to collecting money from the user of the public paid toilet situated at Vellakarai Road, Sattur Taluk, Virudhunagar District for a period of three years (i.e., 2016-17 to 2018-19).
