PRAYER: Writ Petition is filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorari Mandamus to call for the records in connection with the impugned order passed by the first respondent vide Rc. 4019/2015/G1 dated 03.02.2016 appointing the fourth respondent as H & T Contractor for Kovilpatti Warehouse of the Tamil Nadu Warehousing Corporation



and quash the same and direct the first respondent to open the price bid of the petitioner and appoint the petitioner as Handling and Transport Contractor for Kovilpatti Warehouse for a period of 2 years from the date of award if the petitioner's bid is the lowest bid.

This writ petition has been filed, seeking to quash the impugned order dated 05.02.2016, passed by the first respondent. The petitioner also sought for a direction to the first respondent to open the price bid of the petitioner and appoint the petitioner as Handling and Transport Contractor for Kovilpatti Warehouse for a period of 2 years from the date of award, if the petitioner's bid is the lowest bid.

2. When the matter is taken up for hearing, learned counsel for the petitioner has submitted that this writ petition has become infructuous, as nothing survives for further adjudication in this matter.
