2.The learned Special Government Pleader takes notice for the respondents 1 to 3 and Mr.M.Mahaboob, learned counsel takes notice for R4. By consent, the writ petition itself is taken up for final disposal.

3.The learned counsel for the petitioner submitted that it would suffice if the representation of the petitioner is disposed of, on merits and in accordance with law, within a time frame to be fixed by this Court.

4.In view of the limited scope of the prayer, without going into the merits of the matter, 3rd respondent is directed to consider the representation of the petitioner, dated 20.01.2016 on merits and in accordance with law and pass appropriate orders within a period of 8 weeks from the date of receipt of a copy of this order.

5.With the above direction, the Writ Petition stands disposed of. No costs. Consequently, connected W.M.P.is closed.
