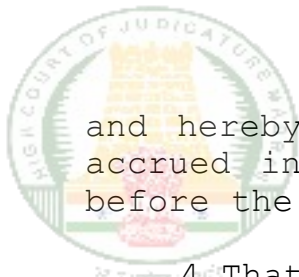
DECREE: This Civil Miscellaneous Appeal coming on for hearing on this day and upon perusing the grounds of Appeal, the order of the Motor Accidents Claims Tribunal,(Sub Court) Pudukottai and the material papers in this Appeal and upon hearing the arguments of Mr.P.Ganapathi Subramanian, Advocate for the Appellant and of Mr.Royale Emmanuel, Advocate for 2nd respondent, this Court while allowing the Appeal in part, and in modification of the award of the tribunal below, doth order and decree as follows:

1.that the award of the Motor Accident Claims Tribunal,(Sub Court),Pudukottai dated 13.06.2013 made in M.C.O.P.No.53 of 2011 be and hereby is enhanced from Rs.1,00,500/-(Rupees one lakh and five hundred only) to a sum of Rs.1,95,000/-(Rupees one lakh ninety five thousand only) along with interest at the rate of 7.5% per annum from the date of petition till date of realisation and proportionate costs;

2.That the Second respondent/Insurance Company be and hereby is directed to deposit the entire award amount with accrued interests and costs, less the amount already deposited, if any, within a period of four weeks from the date of receipt of a copy of this judgment;
