PRAYER IN WP(MD) No.13729 of 2017:

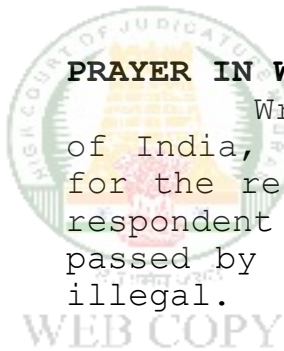
