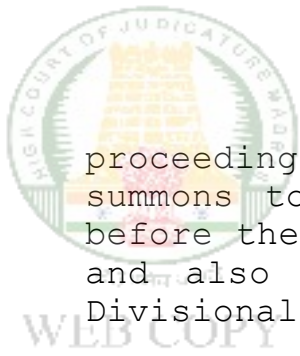

proceedings under Section 111 of Cr.P.C. and issued impugned summons to the petitioners and directed the A party to appear before the Revenue Divisional Officer on 17.06.2013 at 10.00 a.m., and also directed the B party to appear before the Revenue Divisional Officer on 19.06.2013 at 10.00 a.m.

3. Aggrieved over the same, the petitioners filed this criminal original petition, in the year 2013. Therefore, I do not find anything survives for adjudication in this case, after a lapse of four years. Accordingly, this criminal original petition is closed giving liberty to the petitioners to work out their remedy in the manner known to law, if so advised. Consequently, connected miscellaneous petitions are closed.
