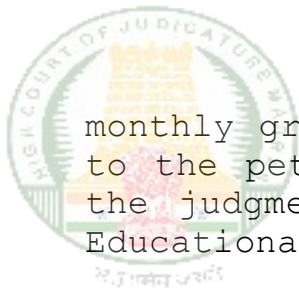

To grant an AD Interim Direction to direct the Respondents 1 to 3 to release the monthly grant in order to enable the 4th respondent to pay salary to the petitioner, pending disposal of this writ petition WP(MD). 1739/ 2016 filed under Article 226 of the Constitution of India, praying this Court To issue a writ of Mandamus direct the respondents to pay arrears of salary from the month of November 2012 and further release the
