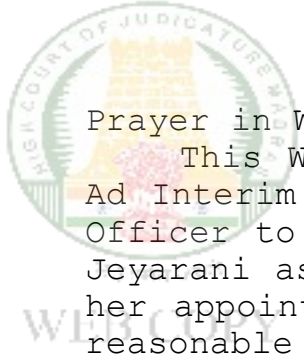

Arul Jeyarani as Tamil Pandit in the petitioner school w.e.f the date of her appointment on 02.06.2014 with all attendant benefits within a reasonable time as may be prescribed by this Honourable Court, pending disposal of the Writ Petition.

Prayer in WP(MD). 830/ 2016 :

This Writ Petition has been filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus, to call for the records relating to the impugned proceedings issued by the 4th respondent District Educational Officer in A.Thi.Mu.No.3313/Aa4/2014 dated 03.07.2014, quash the same and further direct the 4th respondent District Educational Officer to approve forthwith the appointment of G.Arul Jeyarani as Tamil Pandit in the petitioner school w.e.f the date of her appointment viz., 02.06.2014 with all attendant benefits including the arrears of salary and allowance.
