When the matter was taken up for hearing, the learned Special Government Pleader produced a copy of the Government Order in Na.Ka.No.4186/21/2010, dated 05.07.2017, by which the services of the petitioners were regularised. But, the learned counsel for the petitioners would submit that the said order cannot be termed as absolute compliance of the order passed.

2. If that is the grievance of the petitioners, the remedy lies elsewhere. Inasmuch as Government Order has been passed, we do not find any willful disobedience on the part of the



respondent. Hence, the contempt petitions are closed with liberty to the petitioners to work out their remedy in the manner known to law.
