Prayer in WP(MD) . 17058/ 2014 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Certiorarified Mandamus, call for the records in respect of order passed by the 3rd respondent in OM.U.NO.1515/B5/2014 dated 27.8.14 and quash the same and consequently direct the 3rd respondent to approve the appointment of the petitioners from 10.01.2014 and further direct the respondents to disburse all service and monetary



benefits to the petitioner from 10.01.2014 and pass such further of orders as this Honble court.
